<p>This is the percentage of students entering the institution as full-time, first-time (no prior postsecondary education), degree/certificate-seeking undergraduate students who entered between September 1, 2016 and August 31, 2017, and who completed their programs within 150 percent of normal time to completion. Disaggregated graduation rate data displayed by gender, race/ethnicity, and financial aid status are based on the same cohort of students. Because many of our students have previous college experience, the number of students measured in this rate is relatively small as compared to the total campus population.</p> <p>The overall Graduation Rate for this campus is 54%, as reported in the 2019 – 2020 IPEDS Graduation Rates Survey.
